Foreword

This European Standard has been prepared by the Technical Committee CEN/TC 112 "Wood-based panels", of which the secretariat is held by DIN.

This standard is one of a series of standards for the classification of plywood by surface appearance. The other parts of this series are listed in clause 2 and Annex A.

This European Standard shall be given the status of a National Standard, either by publication of an identical text or by endorsement, at the latest by November 1995, and conflicting national standards shall be withdrawn at the latest by November 1995.

According to the CEN/CENELEC Internal Regulations, the following countries are bound to implement this European Standard: Austria, Belgium, Denmark, Finland, France, Germany, Greece, Iceland, Ireland, Italy, Luxembourg, Netherlands, Norway, Portugal, Spain, Sweden, Switzerland and the United Kingdom.
